## **DISCLOSURE REGARDING THE DISCIPLINE ON THE PROTECTION OF PERSONAL DATA**

Dear Customer,

this information is provided pursuant to and by effect of art. 13 of Regulation (EU) 2016/679 (hereafter "GDPR"), concerning the protection of individuals with regard to the processing of personal data.

### **Purpose and legal basis of the processing**

Your personal data will be processed for the following purposes:

- perform obligations arising from a contract or respond to specific requests before and after the execution of the contract;
- comply with legal obligations of an administrative, accounting, civil, tax, regulation, community and / or non-EU legislation;
- manage any eventual dispute;
- only upon your request, send by e-mail links to company videos presenting our products.

The processing, necessary for the pursuit of the such purposes, is based on the principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

### **Data retention period**

Your personal data will be kept for the time necessary for the above mentioned purposes and, even after the termination of the contract, for the fulfilment of any obligations related or arising from the contract for the period of time prescribed by the laws in force at the time and according to the limitation period of the rights deriving from the contract itself.

### **Nature of the provision of data and consequences in case of refusal**

The provision of data is mandatory for all that is required by legal and contractual obligations and therefore any refusal to supply them in whole or in part may give rise to the impossibility for the Company to execute the contract or to correctly perform all the obligations related.

### **Recipient categories**

Exclusively for the purposes specified above, all the data collected and processed can be communicated to internal figures authorized to processing for their respective duties, as well as the following categories of external subjects:

- sales agents who manage the reports on behalf of the Data Controller;
- credit institutions / lenders;
- credit insurance company;
- credit recovery companies, commercial information companies, factoring companies, consulting companies;
- professionists or service companies operating on behalf of our Company;
- Public and private bodies, also following inspections and checks.

These recipients, if they were to process data on behalf of our Company, will be designated as data controllers, with a specific contract or other legal document.
