DISCLOSURE REGARDING THE DISCIPLINE ON THE PROTECTION OF PERSONAL DATA

Dear Supplier,

this information is provided pursuant to and by effect of art. 13 of Regulation (EU) 2016/679 (hereafter "GDPR"), concerning the protection of individuals with regard to the processing of personal data.

Purpose and legal basis of the processing

Your personal data will be processed for the following purposes:

- perform obligations arising from a contract or respond to specific requests before and after the execution of the contract;
- comply with legal obligations of an administrative, accounting, civil, tax, regulation, community and / or non-EU legislation;
- manage any eventual dispute;
- manage any supplier qualification and monitoring process

The processing, necessary for the pursuit of the such purposes, is based on the principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Data retention period

Your personal data will be retained even after the termination of the contract for the performance of all the obligations connected or arising from the contract for the period of time prescribed by the laws in force at the time and according to the limitation period of rights arising from the contract itself

Nature of the provision of data and consequences in case of refusal

The provision of data is mandatory for all that is required by legal and contractual obligations and therefore any refusal to supply them in whole or in part may give rise to the impossibility for the Company to execute the contract or to correctly perform all the obligations related.

Recipient categories

Exclusively for the purposes specified above, all the data collected and processed can be communicated to internal figures authorized to processing for their respective duties, as well as the following categories of external subjects:

- credit institutions / landers;
- - professionals or service companies operating on behalf of our Company;
- - Public and private bodies, also following inspections and checks.

These recipients, if they were to process data on behalf of our Company, will be designated as data controllers, with a specific contract or other legal document.

Data transfer to a third country and / or an international organization

Your personal data will not be transferred to non-European third countries.

Rights of interested parties

You have the right (see articles 15 -22 of the GDPR) to ask our Company to access your personal data and to correct them if they are inaccurate, to delete them or limit their treatment if the conditions are met, or to oppose their processing for legitimate interests pursued by our Company, as well as to obtain the portability of the data provided by you subject to automated processing based on your consent or contract. You also have the right to revoke the consent given for processing purposes that request it, without prejudice to the lawfulness of the processing carried out until the moment of revocation. You also have the right to lodge a complaint with the competent supervisory authority on the subject, Guarantor for the protection of personal data.
